**IF STATE APPROVED PLANS ARE REQUIRED, PLANS & LETTER MUST BE SUBMITTED WITH PERMIT APPLICATION.**

Sanitary sewer laterals are the responsibility of the property owner. The City of Waukesha will not field mark lateral ends.

Lateral locations and Sewer-Only Applications can be obtained at the City Engineer's office.

**We request that the outside sewer maintain a pitch of 1/8" to 1/4" per foot 15 feet on either side of the lotline for commercial and industrial jobs.**

**\*\*NEW PLUMBING WORK IS REQUIRED TO BE UNDER TEST AT THE TIME OF INSPECTION\*\***

**DOUBLE FEES SHALL BE CHARGED IF WORK IS STARTED BEFORE PERMIT IS ISSUED.** This permit is in effect for 18 months from date of issue unless work is not started within 120 days of issue date, or activity ceases for more than 120 days, after which this permit shall lapse.

**WORK COVERED BEFORE INSPECTION WILL BE REQUIRED TO BE TOTALLY EXPOSED FOR INSPECTION.**
